

New Earth Nation announces the first Initiative of the Tribunal for Natural Justice

You are invited to participate in a live Grand Jury Investigation! Your Participation is needed to secure the future of the people of Planet Earth....

BACKGROUND:

New Earth Nation launched a major Global Initiative March 20/21 2014. Visionary leaders laid out a work in progress to help birth the New Earth.

New Earth Nation sent out a clarion call. Would the people consciously choose to participate in the most unpredictable time in human history? Peace and Prosperity is our birthright but it has been stolen out from under us. Would we choose a New Earth free from the crippling shackles of Corporations posing as Governments? Would we choose to help steer our wobbling ship in a sane direction that serves the needs of all?

Within days of the Launch, over 200,000 people signed up. They clicked a Facebook page. They signed the DECLARATION OF INDIVIDUAL SOVEREIGNTY. They expressed their desire to be active participants in the global transition. They intend to be part of the 99% who have a say in “How Things Work” on Planet Earth.

Visionaries have worked for months to create working models of the New Earth Institute, New Earth Exchange, New Earth Communities, and more, all designed to retain the separation that ensures that NEN can never become another defacto governmental organization. New Earth Nation is a Jurisdiction set apart in order to provide the reflection necessary to understand why that is critical to the success of a New Earth.

Volunteers from all walks of life have stepped up to offer their particular expertise. NEN has quickly become THE Planetary touchstone for the transition. It is our job, as volunteers, to provide the tools and resources that anyone could ever need, but to do so in a way that makes it easy.

The Tribunal for Natural Justice announces its first Initiative and invites global participation.

TNJ sets it's first major task: Help people understand the current system of Law and why we, the people, can and must change it.

TNJ will present a series of Webinars where you, the participants, will be asked to serve on the Grand Jury

Participants will first attend a preliminary series on what a Grand Jury is, what function it serves in Civil Society, how the Jury is selected, and how it must function separate from the Administrative Agencies who took over unlawful control of the Judiciary. Participants will have the opportunity to interact with leaders who are successfully reconstituting lawful Grand Juries in America.

On the day the Grand Jury is convened via the Webinars, Participants will be sworn in. You will be asked to complete the Webinar Series, which will be recorded in case you miss any of the evidence gathering. You will function as a team exactly like a formal Grand Jury.

The Grand Jury will be asked to determine whether the Prosecution has provided irrefutable evidence, black ink on white paper, of the facts alleged. The Grand Jury will hear competent fact witnesses, expert testimony, exhibits that prove material facts, Congressional Records, Court findings, historical documents, depositions of various ACTS passed by Congress, and more.

The Prosecution will present it's case, the Grand Jury will deliberate, and issue it's finding: Is there enough evidence to bring the Offenders to trial?

The Prosecution will present evidence that a group of unscrupulous Corporations under the umbrella of an International Parent Corporation, BANK OF INTERNATIONAL SETTLEMENTS, (BIS) took over the United States government, (and other governments); that the United States government is under a permanent state of National Emergency; that the Courts act under orders of the United Nations and the International Monetary Fund; that the Courts are nothing more than Administrative Agencies under the control of the BIS, ex rel; and that BIS, ex rel, set up a Voluntary Slavery Registry to deliberately steal the commercial and spiritual energy of the inhabitants.

It is one thing to hear rumors. What does the evidence tell a properly seated Grand Jury? You get to decide:

The Prosecution will present this case before the Grand Jury:

1. There is evidence to suggest that a group of unscrupulous Corporations owned by private individuals took over the government of the United States – and other governments – but at issue is the USA.
2. There is evidence to suggest that this group, under one International Parent Corporation, were fully exposed, properly noticed by their own Rules, and were lawfully and legally foreclosed by a series of UCC filings from 2011 – 2012,
 - 2.1. By the same methods used by the Administrative Courts to foreclose on home mortgages to steal the people's homes,
 - 2.2. by the same methods used by DCSS and the Courts to foreclose on a Child Support Obligor Lien that remands an unsuspecting parent to Debtor's Prison,
 - 2.3. by similar methods used by the IRS to steal property or confiscate funds out of your bank account
3. Who are the private owners of the International Parent Corporation? What subsidiaries are under the same umbrella? What proof can the Prosecution provide?
4. According to their own Rules, was this IPC lawfully and legally foreclosed?
5. Is there evidence to suggest that the United States, specifically, has been under a permanent state of National Emergency since 1933,
 - 5.1. That the International Parent Corporation had a long-range plan in place to take over the governments of the world,
 - 5.2. That the Bankruptcy Act of 1933 gave them the means to take over in the USA,
 - 5.3. That the Bankruptcy of the United States set the Courts and Banks up to function under UN/IMF supervision as Administrative Agencies of the International Parent Corporation,
 - 5.4. That a series of CONGRESSIONAL ACTS set up the people to provide the FULL FAITH AND CREDIT to back the Debt under receivership to the IPC.

6. Is there evidence to suggest that the people are treated as Alien Enemies of the Corporations?
7. Is there evidence to suggest that the Court Officers and Municipalities use this against the people to steal funds intended for their use by BLOCKED GRANTS used instead to run their private Corporations?
8. Is there proof that those Agencies posing as “Public Officials” are NOT but are in fact “private entities, CORPORATIONS?”
9. Is there evidence to suggest that this International Parent Corporation deliberately set out to create “Voluntary” Slavery Contracts by using a Commercial Registration Scheme similar to the format used by Plantation Owners to register the birth of a baby as their property?
10. Is there evidence to suggest that the Commercial Slavery Registry can be traced right down to the County Level, to the hospital, to the record of the birth of a new baby, to the reason a footprint is stamped on the record?
11. Is there evidence to suggest that the Birth Event creates an Ownership Title claimed by the STATE OF BIRTH that can be traced as a subsidiary of the IPC?
12. Is there evidence to suggest that this Ownership Title gives the IPC the ability to create the money supply based upon the future worth of the slave?
13. Is there evidence to suggest that the IPC created methods, such as the DTCC, wherein the people deposited the VALUE, the IPC used an ASSESSED VALUE that was supposed to be used for the maintenance of the people, and then stole it to run their world while keeping the people destitute?
14. Is there evidence to suggest that the Courts are nothing more than a Military Tribunal, with Admiralty and Ecclesiastical Overtones, that function as Administrative Agencies under the control of the IPC?
15. Is there evidence to suggest, from Third Party Intervenor documents filed into the Court, that a living natural person is considered a “dead man walking” when dealing with the courts?
16. Is there evidence to suggest that it is the SLAVERY CONTRACT that creates a CORPORATE FICTION OWNED BY THE STATE that is the real party of interest in the Administrative Courts?
17. Is there evidence to suggest that the Court acts as a Bank, to allow the Agents to set up SLAVERY BONDS and file them in CRIS - Court Registry Investment System - to steal the funds from the people, profit from them, and profit again when they “warehouse” them in the Penitentiary so they can “repent of their sins”?
18. Is there evidence to tie the Obligor Liens and other Commercial Paper created by the Courts into the duties of the Probate Judge, to further prove that the courts are administering the Estates of the Dead?

You, the Grand Jury, will have opportunities to interview the witnesses. Ask for clarification. Request further documentation. Ask questions until you feel ready to deliberate with your fellow Jurors.

Jurors will be asked to determine if there is sufficient evidence to indict the International Parent Corporation and it’s subsidiary corporations:

1. Did this IPC take over the government of the United States?
2. Did this IPC deliberately mask the role of it’s Administrative Agencies by posturing them as “Public Officials?”
3. Are the Courts functioning as Administrative Agencies of the IPC?
 - 3.1. Are they in fact acting as Military Tribunals?
 - 3.2. Are the Courts charging the Corporate Fiction registered as a Slavery Contract rather than the living natural person?
 - 3.3. Are the courts using SLAVERY BONDS as a means to enrich their Agents and their corporations?
4. What rules govern the Administrative Courts?
 - 4.1. Are the courts following their own Rules?

5. Was this International Parent Corporation and its subsidiaries properly foreclosed according to their own Rules?

Once the evidence is presented and deliberated upon, if the findings warrant a True Bill, then the Case will be presented before NEW EARTH'S TRIBUNAL OF NATURAL JUSTICE.

Many, many extraordinary people have amassed irrefutable evidence that every statement above can be conclusively proven to be true. They will present the evidence, provide exhibits and documents so that each Juror can have ample time to read and study and ask further questions.

Experts in their field will help Jurors understand the UCC, Administrative Procedures, Rules of the Court, the Commercial Registry System, How the Courts are supposed to function under 28 USC Judiciary, and how the Banks are supposed to function under 12 USC – Banks and Banking.

Jurors will examine the Federal Reserve Act of 1913, the Social Security Act of 1935, the Alien Registration Act of 1940, the Civil Rights Acts and how they apply to the natural person, the Fourteenth Amendment, and other pertinent Congressional Records.

Yet the evidence is so concise, it can be presented in a short span of time. By the end of this Webinar Series, Jurors will have great insight into why our current system serves only the Rulers. Jurors will grapple with the means and methods used by the 1% to set themselves up as Divine Rulers with presumption of dominion over all things, living or dead.

Jurors will understand Contract Law, and how the Slavery Contracts have been used to create a population of the "Civilly Dead."

Jurors will have an in-depth understanding how Civil Law should function based on the Grand Jury model.

According to one expert witness, it only took 80,000 people filing complaints in the Court Systems to repeal Prohibition.

This Grand Jury experience will expose you to the means and methods used by Corporations posing as Government to steal the birthright of the people. You will be astounded to learn how their Monopoly Money Game has ruled your life. Your focused attention on the evidence will start a domino effect that will alter life on Planet Earth forever.

The aim of the People's Grand Jury is to bring many of the leaders to the same table. As the word spreads, and as leaders are asked to give their expert testimony, and anyone with credible evidence is urged to bring it forward, we will create the SUPPORT NETWORK that will be required for Phase Three.

The Second Task of TNJ is to set up a simple but effective EXIT STRATEGY.

Goal: Webinar Launch: July 4, 2014. Invite Registration to Participate in the People's Grand Jury; State the Case; Explain why it is necessary for the people to DECLARE INDEPENDENCE from the Corporations posing as Governments.

1. NEN has called upon leaders throughout the world to participate in the development of a DECLARATION OF INDIVIDUAL SOVEREIGNTY.
2. Individuals who wish to lawfully and legally reclaim stolen birthrights can follow the procedures outlined to notify the rogue corporations that they no longer stand under their dominion.

3. This action is designed to cancel any presumption that an unlawful, unconscionable slavery contract ties anyone in as property of a private Corporation.
4. This method is designed to energetically and physically free the people of the world from the slavery contract that is at the heart of the scheme of Corporations posing as Governments.

NETNJ will act as the witness to the birth of our collective Independence. The support system to register each DECLARATION OF INDIVIDUAL SOVEREIGNTY already resides within the New Earth Portal.

NETNJ intends to create so much excitement around the birth of the NEW EARTH that we will collect at minimum one million signatures before December 21, 2014.

It only takes the square root of 1% of the population to create the needed impetus for change.

Like the Walls of Jericho tumbling down, when enough trumpets sound, the people will be in charge of the New Earth!

HOW TO ACCOMPLISH THE EXIT STRATEGY:

Keep it simple. Set up Webinars, Lead Pages, Facebook, etc. to fully explain the process – teach what it means – answer questions.

1. GOAL: ONE MILLION SIGN THE DECLARATION OF INDIVIDUAL SOVEREIGNTY on the NEN website and partner websites by December 21, 2014.
2. Set up a working team with Divine Province, Australian Indigenous leader Jagamarra, Moorish American leaders who have been successful declaring Status, and other groups who have worked on this issue to join with us to create a method we can circulate far and wide.
3. Preliminary ideas as I understand the process to get the conversation started:
 - 3.1. Individuals print out five copies:
 - 3.2. They will personally be responsible for witnesses, mailing, whatever the team determines is required, but at minimum to:
 - 3.3. Secretary of State of the birth state
 - 3.4. Alien Property Custodian of the Country where domiciled
 - 3.5. Department of the Treasury
 - 3.6. Vatican/City of Rome – since they appear to be the instigators of the original ownership claim, stole the spiritual energy through the soul/sole/footprint stamped on the birth record, etc.
 - 3.7. Two copies to NETNJ headquarters
 - 3.7.1. One to be scanned with wet ink signatures as evidence that the person has stepped OUT of the Jurisdiction of the Corporations
 - 3.7.2. To be displayed prominently at the December Festival - whether digitally or under glass to draw attention to the numbers willing to leave the Old States behind
 - 3.7.3. One to be stamped and mailed back for the person's Estate records.
 - 3.7.4. A copy can be extracted from their Estate Records and used in Courts to prove that they have cancelled the Slavery Contract and can no longer be held under any presumption of fake Jurisdiction (We explain how to do this)
4. Each person would pay \$5.00 for this Certification Process, or an amount to be determined based upon the budget – keep it as simple as possible. The record is already in the website registry – no need to re-enter it. Merely scan, stamp, and send back. Ask for a self-addressed stamped envelope to return the stamped and sealed document. (Apostille it???)
5. Each person would be encouraged to join the ONE MILLION DECLARATIONS – whereby they follow the above procedure and also commit to fund the administrative side of NEN by pledging \$1.00 a month.

6. This is an ACTION STEP – it enrolls people in the process, gets them thinking about how a Sovereign acts, gives them another tangible lesson in the law of the contract, and forces them to think about sending these documents to the people they have allowed to be in charge of all their affairs. Forces them to face their fears: What could happen to me if I take this action?
7. By taking action and following through, this will empower people to pay more attention to how the world works.
8. It will also give NETNJ and our partners feedback in how committed the people are, and how effective we are as leaders.
9. PUBLISH THE WEEKLY RESULTS on the website, on lead pages, FB, etc. feature in newsletters – Keep the momentum going! As soon as we meet the goal of ONE MILLION – plaster it everywhere, etc. etc. (I still remember when Atlanta reached One Million in population – what a fanfare!)
10. This is a MAJOR PUBLICITY TOOL as well as a major organizing tool. Always keep that in mind.

TASK THREE: SETTING UP THE SUPPORT NETWORKS

Phase III would be the Trial itself. We will use the E-Democracy set-up. The people of the world will be the Jury who will hear the Case and decide for themselves. We will not depend upon a small group of Judges with special interests to set us free. We will set ourselves free by our own voting procedures.

We will call upon the leaders of the various organizations who have made it possible for us to now complete the task. These are the heros/heroines who have gone down into the underworld to bring back the boon that will help all of humanity move through this process much faster and much cleaner than those who have gone before. These leaders have pledged to make themselves available to help everyone navigate through the obstacles that the dying system will place in our path.

These extraordinary people have banded together to expose the fraud in the Mortgage Foreclosure Mill. Others have exposed the OBLIGOR LIEN that places unwary parents at the mercy of Debtor's Prison. Still others find ways to navigate through the courts. Others help to write the paperwork needed for your individual challenge. Still others are the free thinkers who have articulated the concepts to set up the Exit Strategy.

Seasoned leaders will provide templates, tools, and manuals, but most of all a support network. On our path to Absolute Sovereignty, we will learn to be both proactive and reactive. We can deal with whatever task presents itself and quickly share that information throughout the network.

NETNJ is just one small segment of the growing support network across the world. There is room at our table for all. Let's help each other wake up from the nightmare that is somebody else's dream. Let's birth a New Earth that will accommodate all our dreams.
